## **A Statement of the Applicant Company**

## **C Declaration by Applicant concerning Application for Security Background Check**

I agree to electronic storage of my personal data. I hereby acknowledge the Airport User Regulations and the ID-Card Regulations as well as all other regulations in force at the airport.

I confirm that the Day Pass will only be used by myself and only for official purposes.

I agree and accept that

- I will be subjected to a background check on the basis of Art. 7 Aviation Security Act,
- my data will be forwarded to and stored at the responsible aviation security authority, the Frankfurt am Main Commissioner of Police, for the purpose of the background check,
- the data will be transmitted without further consent to the responsible aviation security authority for the periodic review,
- the authorities involved pursuant to Art. 7 Para. 2 Clause 3 Aviation Security Act will forward findings pertinent to security to the responsible aviation security authority,
- the aviation security authority will obtain information from criminal prosecution authorities in cases of doubtful trustworthiness.

I confirm that I have provided the information on this form to the best of my knowledge and that during the past 24 months I have not filed an application for a security background check by the Aviation Security Authority for granting authorization to access non-public or security-sensitive areas and facilities at Frankfurt Airport.

I agree to and accept that the personal data provided on this form as well as information resulting from the security background check will be electronically stored with the responsible Aviation Security Authority. I have received / acknowledged the results regarding the security background check of the Aviation Security Authority.

## **D Confirmation of the Designated Accompanying Person for Day Passes Marked with the Limitation "Only with Accompanying Person"**

The regulations in the ID-card regulations governing "Escort Authorization" and "Violations" apply.

The designated person with the accompanying responsibility must be willing to continuously stay with the person holding the Day Pass in the above-listed areas or must organize accompanying by a suited and authorized person.

If the designated person with the responsibility of accompanying transfers his/her function to another person, then he/she must precisely inform the next accompanying person of the extent of his/her responsibilities. The received information sheet must be passed on to the accompanying person.

Any person accompanying the person with a day pass must inform the designated accompanying person verbally that he/she will conduct supervision properly and accepts the regulations given in the information sheet.

The designated accompanying person must himself/herself have authorization to access the specified areas.
